1. Entrance Fees are applicable to Subscription Categories A, D, E and O. The new applicant may choose which joining fee they will pay, they can opt to pay 50% of the full subscription or 75% of the full subscription with 50% of that amount repaid in vouchers that may be used in payment of Bar and Restaurant bills only within 6 months of the joining date.

IMPORTANT NOTES

1) **The age requirement** is as at 1st January (or at date of joining if during the year). Where Family Membership is concerned, the category of membership shall be decided by the age of the older member.

2) **Student Membership** shall be only Individual Membership. **Overseas Membership**: member must be permanently resident outside the UK at 1st January (or at date of joining if during the year) and for the whole subscription year. Subscriptions are linked with category D. **Temporary Membership**: eligibility and subscriptions may be varied by the Executive Committee as appropriate.

3) **Personal Members may transfer** between categories of Personal Membership on payment of any additional and appropriate subscription or entrance fee. No repayment of entrance fee or subscription shall be made.

4) **Members shall be entitled to a discount of 2%** if their subscriptions are paid in full on or before the 1st January in a subscription year. Members who have not already agreed to pay by Direct Debit are requested to fill in a DD form now to be assured of the discount (for annual payments only); please specify "Annual" on DD form.

5) **Monthly payment will only be accepted** by Direct Debit - please specify "Monthly" on DD form. Please note monthly instalments include a 12% Administration charge.
