NOTES REGARDING APPLICATIONS FOR MEMBERSHIP

Applicants for membership must be proposed and seconded by Full Members of the Club, and should have been known to the applicant personally.

Proposing members are reminded that they will be required to accompany the applicant.

Applicants who, for any reason, are unable to have their applications proposed or seconded by Full Members of the Club may submit an application supported by two written character references, at least one of which should preferably be from a responsible officer of a Club or organisation of which the applicant is a member.

References should be addressed to the Chairman of the Membership Committee and should accompany the application.

Please note that the category of Family Membership applies to a husband and wife or partners in an established common law relationship. It also applies to members' children aged 17 and under. The rate for Family Membership offers a beneficial subscription rate compared with accumulated individual rates. Applicants for Overseas category must reside permanently outside the UK excepting the Channel Islands. Following interview, applicants names will be put forward to the House Committee for ballot.

If elected to membership, applicants will be notified in writing and invited to submit the appropriate entrance fee and pro-rata subscription to the Club. Membership will commence upon receipt of acceptance and fees.
